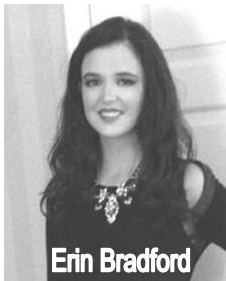
Contestant will appear in THEME WEAR only. NO formal wear.
